Burlington, Camden and Gloucester counties in New Jersey; and New Castle County in Delaware

**WHAT? : Celebrate recent grassroots achievements in the preservation of individual historic residential homes (*Projects must have been substantially completed in the last two years*):**

Homeowner Restorations • Professional Restorations • Interior Restorations • Exterior Restorations • Sensitive Additions

**WHO? : A panel of preservation professionals and neighborhood representatives chooses award winners based on these criteria:**

The quality of the work • How the project impacted neighborhood revitalization • Demonstrates a Grassroots Effort

**HOW? : Submit the attached nomination form and include the following attachments:**

- A brief description of the project (No more than two pages)
- Sufficient supplementary materials – e.g. a minimum of 3 “before” and 3 “after” images . Images must be 300dpi or higher, on disc should be included in nomination packet. (Materials will be returned, if requested).
